Order & Cancellation of Order

You recognize to accept Terms and Conditions by placing an order.
All Orders are subject to acceptance by MATHEA. All Products are subject to availability.
You may cancel a contract and obtain a refund any time within 14 days after receipt of Products.
Your claim should be written.

If the order has already been sent out when the cancellation is made, the customer must take reasonable care to make the parcel readily available for carrier to collect.

Payment

Payment can only be made by bank-transfer, cash on delivery and PayPal

Returns and Exchanges

You have a withdrawal period of 14 days, counting from the day of receipt, to return the products you ordered for a refund; if you have changed your mind, if the items received do not match the description given or if they are defective.

Please take great care in completing the Return Form enclosed with the delivery, and make sure you state your precise reason for returning the goods. This form must be enclosed with the returned parcel. You will be refunded for the returned product within 30 days at the most, counting from when it is received by.
